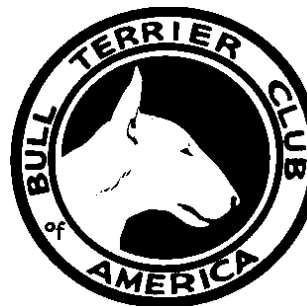

SHOW REGULATIONS

The show site will be accessible at 8:00 AM, Friday, March 12, 2021
The show site will be accessible at 8:00 AM, on Saturday, March 13, 2021 and Sunday, March 14, 2021.

A recording fee of 50 cents will be required for each dog entered at any license or Member Club show, obedience trial or tracking test. This recording fee is to be collected by the show giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only (American Kennel Club Rules, Chapter 14, Section 2).

Entry fees are \$30.00 for regular classes., \$25.00 for Puppy Classes and Bred By Exhibitor. These fees include a \$3.00 event fee and a 50 cent American Kennel Club recording fee. Sweepstakes entry fee is \$15.00. Dogs entered in the American Bred Classes must have been whelped in the United States by reason of a mating which took place in the United States (American Kennel Club Rules, Chapter 6, Section 8). Foreign dogs (dogs not whelped in the USA or Canada) are eligible for Puppy and Open Classes effective, January 1, 1985. Make all checks and money orders payable in U.S. funds to DOG SHOW IN A BOX. Checks or money orders must be sent with entries.

Telephone, Telegraph, fax and unsigned entries cannot be accepted. Entries not on official entry forms and photocopies of entry forms without Agreement and Rules on the reverse side of the official AKC entry form are not accepted.

Return checks do not constitute a valid entry fee. The Show Secretary will add a collection fee of \$35.00 to the amount of each returned check. Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging may be excused. Owners are responsible for errors in making out entry forms, whoever may make such errors. No entry fee will be refunded in event of such error or cancellation of entries after the published closing date. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by the veterinarian or judge or because of riots, civil disturbances or any other cause beyond the control of the Club.

The show giving Club, or their members, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property and further assumes no responsibility for injury to children.

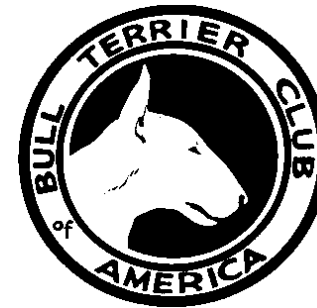

**NOTICE TO EXHIBITORS
COVID-19 RULES ***

**These shows will be held in strict accordance with local, state and facility guide-
lines for Covid-19. The rules applicable on the date of this event will be enforced.
Rules included but not limited to are as follows:**

1. The shows will be closed to the general public. Anyone attending the shows must either be an owner, exhibitor, handler, handler assistant, judge, club members, any hired professionals (photo, video, superintendents, stewards, etc.) Any family member or friend attending the show must enter with an owner or handler of the dog and get an access pass each day. To receive an access pass, temperatures will be taken each day.
2. Masks will be required in all buildings at all times. Disposable masks will be provided to all people working the shows. Exhibitors, owners, breeders, handlers, assistants and approved guests will be required to provide their own masks and any other personal protection supplies necessary to feel comfortable.
3. Social distancing will be strictly enforced to include grooming areas, ring entrances and inside the ring.
4. **BRING YOUR OWN CHAIR.** No public seating will be provided. Social distancing will be strictly enforced.
5. There will be signs throughout the building to help remind people of the rules, safety measurers and to work together. Please observe all signs especially pertaining to entrance and exit doors.
6. Every entrance, in or out will have hand sanitizer stations and hand washing stations will be available.
7. Normal hospitality will be limited.
8. Armband procedure will be different. Exhibitors will be required to know their armband number and pick it up outside the ring. One armband will be issued for the entire weekend.
9. No overnight crating is allowed. Dogs not entered are not allowed in the facility.
10. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.
11. Exhibitors should follow their doctors advice on attending the shows if they are in a high risk group for Covid-19.
